Handgun Purchase Permit Requirements/Instructions

Applicant must complete all questions, be a citizen or a resident alien; have attained at least 30 days residency in Hoke County; be twenty one (21) years of age and provide a **valid North Carolina driver's license or North Carolina State Identification Card with your current address** in order for your application to be processed (note: address on drivers license and application must be the same).

MAXIMUM 2 PERMITS PER YEAR - FEE FOR EACH PERMIT IS \$5.00
